Introduction

The Gram Panchayat Poverty Reduction Plan (GP2RP) is a comprehensive demand plan for local development prepared by the self-help groups and their federations in partnership with the Gram Panchayats. It is an integral aspect of the convergence efforts of the National Rural Livelihoods Mission. GP2RP is the consolidation of the demands for livelihoods, health and sanitation, social security, natural resource development and basic infrastructure development prepared by the poor families who are members of the Self-Help Groups (SHG) formed as part of the National Rural Livelihoods Mission (NRLM). The document will serve as the mission and plan document around which the Gram Panchayat and the community organization network works together to address the basic needs of the poor in the village.

Objectives of GP2RP

- To prepare a comprehensive and an inclusive demand plan for local development under the leadership of the community organisation network in consultation with the local government
- To strengthen the community organisations and their leadership for active participation in poverty reduction activities
- To facilitate organic interface between the SHG federation and Panchayat Raj Institutions (PRI) for the socio-economic development of the village through appropriate mechanisms.

Outline of the Plan

The GP2RP is the consolidation of the 3 registers prepared at the level of SHG, primary SHG federation and federation of SHGs at the GP level. The registers are prepared and maintained by the concerned entity as a plan and for continuous monitoring of its proper implementation. Based on the registers prepared at each level, a plan document is prepared to share with the next level of federation or with concerned authorities.

The components of GP2RP are:

- Self-Help Group (SHG) - Livelihoods and Entitlement Plan
- Primary Federation (Village Organisation/ Ward Level Organisation) - Livelihoods and Social Security Plan
- Gram Panchayat Poverty Reduction Plan (GP2RP)

The major components of the above plan are outlined as given below.

COMPONENTS	DESCRIPTION
Social Inclusion Plan	Plan for inclusion of vulnerable people/household into SHGs of NRLM
Entitlement Plan	Demand for various entitlements based on the entitlement gap identified through Participatory Assessment of Entitlement (PAE) ¹ . The area covered under PAE are employment (MGNREGS), health (SBM) and social security (Pensions, RSBY, ICDS)
Livelihoods Plan	Specific demand for enhancing livelihood through income generation activities like agriculture, animal husbandry, micro enterprises and skilled employment and placement etc.
Credit Plan	Demand for various financial support available from NRLM system as well as through SHG.
Infrastructure Development Plan	Demand for necessary basic infrastructure and for renovation of the existing infrastructure for better service delivery.
Resource Development Plan	Demand for protection and development of natural resources like land, water, forest and other locally available resources.

¹ PAE is an activity through which the beneficiaries were mapped along with awareness generation on various schemes. PAE was conducted with all the existing SHGs.

Part 2 - Process of Preparation of GP2RP in Bowalguri

The process through which each component of the GP2RP prepared is detailed down along with rationale of each component. The plan components developed by Navauday SHG of Markaz VO (represented in green colour tables) and Markaz VO in Bowalguri GP (represented in blue colour tables) are used for illustrating the process. The VO data represented here is from 16 constituent SHG of Markaz VO. Similar SHG and VO level document were developed by all 96 SHGs and 7 VO in Bowalguri GP.

1. Social Inclusion Plan

The objective of 'Social Inclusion Plan' is to bring the poor households who are left-out of the SHG network into SHG fold of NRLM. A discussion on being part of the SHG network and need for inclusion of people is initiated at SHG level in the light of factors of vulnerability/exclusion in the particular village. The households identified by SHGs are verified by VO/CLF and finalised at GP level using the valid documents available like SECC Data and BPL household list. An inclusion proposal to accommodate the left-out households either by adding into the existing SHGs or by forming new SHGs will be the outcome of this part. The plan will be taken up with concerned NRLM functionaries for appropriate follow-up action.

2. Entitlement Plan

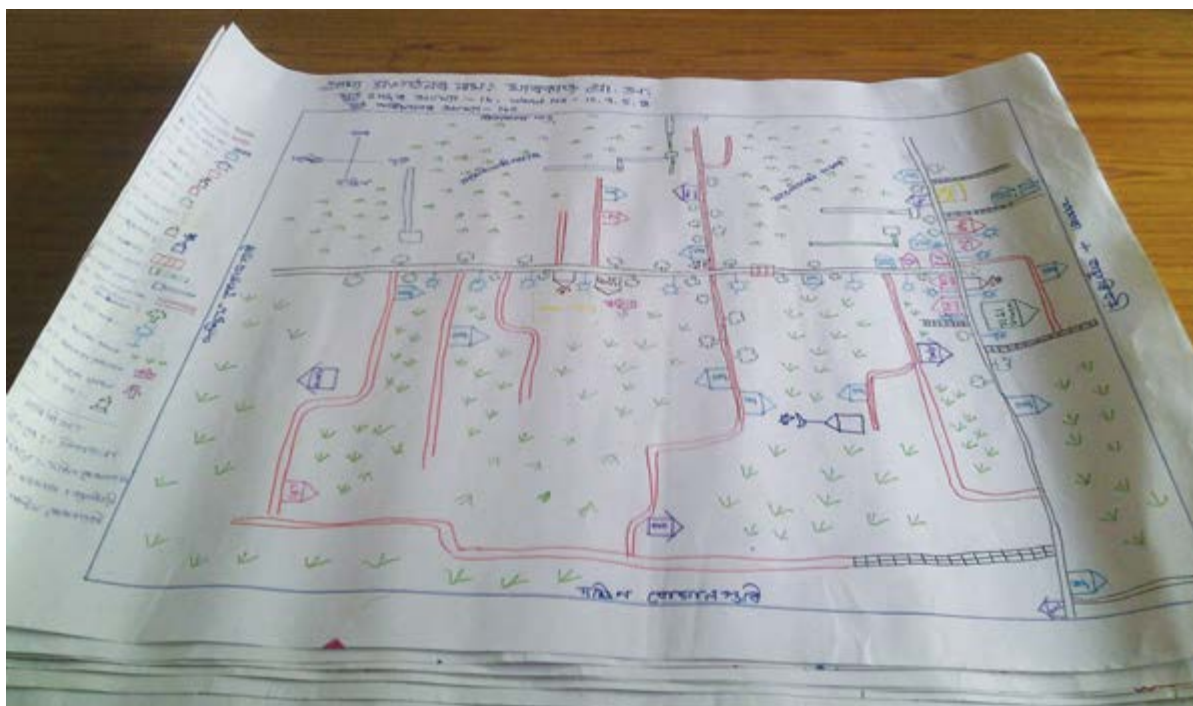

4. Infrastructure Development Plan

The availability of necessary basic infrastructure in the village ensures better service delivery and it can make improvements in the life of the local communities. Major infrastructure includes public amenities, public sanitation and connectivity. So this part captures the demand for new public infrastructures as well as demand for the renovation of existing infrastructures in the village. The demand is captured through a 'Dream Mapping Exercise'¹¹ done at the level of VO/CLF. The possible option to respond to this demand is the GPDP and other financial allocations from Gram Panchayat and Central and State governments.

¹¹Dream Mapping Exercise is an activity through which the VOs identified the public infrastructures and natural resources in their Panchayats and listed down their dream for their village. This helped the SHGs in locating the infrastructure needed in the Panchayats and the potential resources that could be used by the women in enhancing their livelihoods.

Part 3 – General Points

Preparations for GP2RP

The Kudumbashree-NRO team developed the GP2RP concept and process based on its experience of the PRI-CBO Convergence pilot projects in 242 GPs in 6 States. Though each State needs to devise a separate roll out strategy, following steps were generally arrived at, to meet the objective of the activity in the field.

- Preparation of a basic framework for keeping the objective of the activity and the field situation in the mind. The learning from Kudumbashree experiments in Kerala was used to prepare this basic framework.
- Piloting the module in different partner states and making necessary modifications according to the field scenario.
- Orientation of the field team and preparation of State specific Module incorporating the valid inputs
- Capacitation of Local Resource Group along with PR Members at State/Block level.
- Finalisation of the GP2RP Preparation Plan in consultation with CBO and PRI.
- Capacitation of the office-bearers of SHG and VO/GPLF/CLF by the LRG members.
- Preparation of SHG Registers and submission of the Plan to the VO/CLF
- Preparation of VO/CLF Registers and consolidation of the Plans to prepare GP level Register.
- Preparation of different plans by VO/CLF and submission of the same with GP, Departments and SRLM functionaries.

How to take it forward?

- Convening a meeting of the VO leaders and the Local Resource Groups(LRG) with the Gram Panchayat committee for presenting the GP2RP plan
- Discussion on the components of GP2RP, except the credit plan with the Panchayat committee
- Approval of the GP2RP by the panchayat with the signature of the president, secretary and the seal of the Gram Panchayat
- Meeting of the VO leaders with concerned working groups of GPDP for prioritisation
- Submission of the prioritised plan in the Gram Sabha
- Submission of one copy of GP2RP to the BMMU for follow up on the credit plan, micro plan and the inclusion plan

Conclusion

The involvement of the CBO network in the entire GP2RP process was a revelation for the Panchayats about the capability of the CBO to identify and plan for the local economic development of the village. The consolidation of the demand plan of the various livelihood, social security, resource development and basic infrastructural goods and services by the SHG network has boosted their confidence and increased their enthusiasm and leadership skills to involve themselves in matters of public affairs and development.

Kudumbashree NRO provides support to partner-States in two domains:

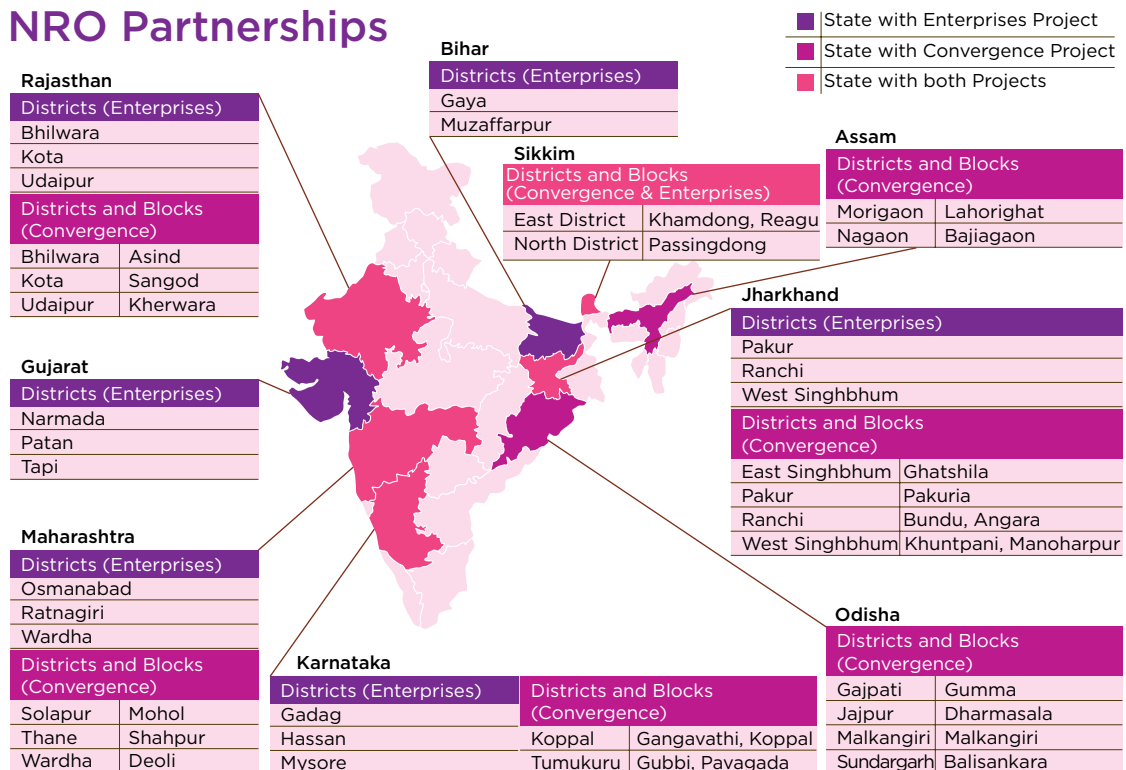
PRI-CBO Convergence Project

Enterprises Project

Building local capabilities, and creating community-based enterprise support systems in the form of Micro-Enterprise Consultants (MEC), for promotion and development of micro-enterprises of the poor are the prime objectives of the Enterprises Project. The Enterprises Project is being implemented in 19 districts across 7 states - namely, Bihar, Gujarat, Jharkhand, Karnataka, Maharashtra, Rajasthan and Sikkim.
